## Terms and Conditions

### Terms and Conditions - Instant Rewards Promotion

1. This promotion is applicable to all new and existing Principal and Supplementary PB Credit/ Debit Cardmembers residing in Malaysia.
2. The promotion is valid from 1 June 2009 to 31 August 2009 (the "Promotion Period").
