2. The promotion is only open to all new and existing Principal and Supplementary PB Credit/ Debit MasterCard Cardmembers residing in Malaysia, except employees of PB and PB's advertising agencies.
3. PB Cardmembers who charge their purchases to their PB MasterCard during the promotion period will be rewarded with the 100% Cash Back, courtesy of PB Card Services & Support, if they are selected as the weekly top spender by MasterCard Worldwide under the "MasterCard Malaysia Mega Sale Carnival 2009 - Spend & redeem Programme". Purchases record shall be conclusive in determining whether a PB Card was used for the relevant purchases (the "Qualified Cardmembers").
