

# **“Riang Raya with DuitNow” CAMPAIGN**

## **TERMS AND CONDITIONS**

### **1. Campaign**

1.1 “Riang Raya with DuitNow” promotion campaign by Public Bank Berhad 196501000672 (6463-H) (“**the Campaign**”) will commence from 19 May 2020 to 07 June 2020, both dates inclusive (“**Campaign Period**”).

### **2. Eligibility and Qualifying Criteria**

2.1 The Campaign is open to all new and existing Public Bank Berhad (“PBB”) and Public Islamic Bank Berhad (“PIBB”) PB Personal Banking customers (“the Customer”). Staff of Public Bank Group are not eligible to participate.

2.2 To participate, the Customer is required to perform a minimum of RM30 DuitNow transaction via PBe or PB engage.

2.3 Customers are allowed to send multiple DuitNow transfers per day. However, only DuitNow transactions to different recipients will be counted.

2.4 Repeated DuitNow transfers to the same beneficiary on the same day will be counted as 1 (one) entry.

2.5 Thirty (30) eligible customers will be selected as winners on each day during the Campaign Period.

2.6 By participating in the Campaign, the Customer: -

- i. agrees that the existing terms and conditions governing the registration and use of the PBe and PB engage shall continue to apply;
- ii. agrees to be bound by these Terms and Conditions and that the decision of PBB shall be final; and
- iii. agrees to access PBB’s website at [www.pbebank.com](http://www.pbebank.com) at regular intervals to view these Terms and Conditions and to ensure that he/she is up-to-date with any changes.

### **3. Campaign Period**

3.1 The Campaign Period spans twenty (20) Campaign Days from 19 May 2020 to 07 June 2020, 23:59:59.

### **4. Campaign Prize**

4.1 Daily Cash Prize of RM50 will be awarded to thirty (30) winners during the twenty (20) days Campaign Period.

4.2 The prizes are non-transferable and are non-negotiable.

### **5. Campaign Mechanism**

5.1 Daily Cash Prize:

- i. With the accumulated entries at the end of each Campaign Day, PBB will select 30 winners based on a pre-determined criteria i.e. total number of eligible entries divided by 30. For example, if there are 3,000 entries for a Campaign Day, the total entries will be divided by 30 and the shortlisted winners will be every 100th eligible participant e.g. 100th, 200th, 300th and so forth.
- ii. Daily Cash Prize winners are not eligible for the daily cash prizes in the subsequent Campaign Days.
- iii. In the event of a duplicate cash prize winner, the next reserved winner will be selected as the winner.

5.2 Each eligible participant is only entitled to win one (1) Daily Cash Prize throughout the Campaign Period.

5.3 The final selection of winners will be at PBB's discretion. PBB's decisions on all matters relating to the Campaign will be final.

5.4 The confirmed winners will be notified via SMS and a winner's list will be published on PBB's website within 30 days from the end of the Campaign Period.

5.5 The Cash Prizes will be credited into the winner's account via DuitNow one (1) day after the winner's list is published on PBB's website.

- 5.6 The crediting of the Cash Prize will be subject to the winner's PBe Internet Banking access and current/savings account being active and subsisting at the time of the crediting.
- 5.7 PBB reserve the right to request proof of identity or to verify eligibility conditions and potential winning entries.

## **6. PBB's Rights**

- 6.1 PBB may amend, delete and/or add to any of these Terms and Conditions with at least twenty-one (21) calendar days' prior notice at PBB's website or by any other approved medium of communication and such amendment, deletion or addition shall become effective on such date as PBB may determine. By participating in the Campaign, the eligible participant agrees to be bound by the amendment, deletion or addition of these Terms and Conditions as aforesaid.
