

# **DUITNOW WITH PUBLIC BANK CAMPAIGN ADDITIONAL TERMS AND CONDITIONS**

This Additional Terms and Conditions shall be read together with the PayNet's Treasure Chest Campaign ("Promotion") Terms and Conditions which is available at [www.duitnow.my](http://www.duitnow.my).

## **1. Campaign**

- 1.1 In line with the Promotion, Public Bank Berhad (6463-H)'s, "DuitNow with Public Bank" promotion campaign ("**Campaign**") shall run from 8 January 2019 until 31 May 2019, both dates inclusive ("**Campaign Period**") unless otherwise notified.

## **2. Eligibility and Qualifying Criteria**

- 2.1 The Campaign is open to all new and existing Public Bank Berhad and Public Islamic Bank Berhad ("**PIBB**") PBe Personal Banking customers ("the Customer").
- 2.2 To participate, the Customer is required to:
- a) Register his / her DuitNow ID with PBB before or during the Campaign Period;
  - b) Send a minimum of RM10 with DuitNow via PBe or PB engage during the Campaign Period;
  - c) Receive a minimum of RM10 in to his / her account via DuitNow during the Campaign Period.
- 2.3 Each DuitNow sent via PBe or PB engage will earn one (1) entry for the Customer.
- 2.4 Any transaction made during the Campaign month\* prior to the Customer's registration will also be considered as an eligible entry provided the criteria stated in (2.2) is achieved.
- \*Only applies to the current campaign month. E.g: If the Customer registered for DuitNow on 15 February. Transactions made from a previous campaign month will not be eligible.*
- 2.5 Staff of Public Bank Group are not eligible to participate.
- 2.6 By participating in this Campaign, the Customer: -
- i. agrees that the existing terms and conditions governing the registration and use of the PBe and PB engage shall continue to apply;
  - ii. agrees he/she has read, understood and hereby expressly agrees to be bound by these Additional Terms and Conditions and agrees that the decision of PBB shall be final, binding and conclusive. No appeal, correspondence, queries or protests will be entertained; and
  - iii. agrees to access the PBB's website at [www.pbebank.com](http://www.pbebank.com) at regular intervals to view these Additional Terms and Conditions and to ensure that he/she is up-to-date with any changes.

### 3. Campaign Period

- 3.1 The Campaign Period spans four (4) Campaign Months from 8 January 2019 to 31 May 2019 as follows:

4 <sup>th</sup> month: April	1 April – 30 April 2019, 23:59:59
5 <sup>th</sup> month: May	1 May – 31 May 2019, 23:59:59

### 4. Campaign Prize

- 4.1 Monthly Shopee e-voucher worth RM20 will be awarded to 2500 winners throughout the five (5) Campaign Months.
- 4.2 E-vouchers are non-transferable, non-negotiable and are non-renewable after expiry date.
- 4.3 The e-voucher is applicable to products for Shopee Mall & Preferred Sellers only.
- 4.4 The e-voucher is not applicable for Diapers & Potties, Baby Food & Baby Formula, Tickets & Vouchers, Mobile Top-ups, Gaming Top-ups, & S-Mart Milo categories.
- 4.5 Not applicable to payments via Buyer-Seller Agreement.
- 4.6 E-voucher is applicable to app purchases only.

### 5. Campaign Mechanism

- 5.1 Once the Customer has performed the criteria stated in 2.2, every subsequent transaction of any value sent with DuitNow throughout the Campaign Period will earn the Customer an additional one (1) entry.
- 5.2 There will be no limit on the amount of entries the Customer can submit.
- 5.3 With the accumulated entries at the end of each Campaign Month, PBB will select 500 winners based on a pre-determined criteria i.e. total number of eligible entries divided by 500. For example, if there are 50,000 entries for a Campaign Month, the total entries will be divided by 500 and the shortlisted winners will be every 100th eligible participant e.g. 100th, 200th, 300th and so forth.
- 5.4 The final selection of winners will be at the discretion of PBB. PBB's decisions on all matters relating to the Campaign, will be final and binding and no further correspondence or attempts to dispute such decisions will be entertained.
- 5.5 Each Customer may only win one (1) monthly Shopee e-voucher throughout the Campaign Period.

- 5.6 The selected winners will receive his / her e-voucher via SMS within fourteen (14) days from the end of each Campaign Month.
- 5.7 Prize winners from the previous Campaign Month(s) will not be eligible to win e-vouchers in the subsequent Campaign Months during the Campaign Period.

## **6. PBB's Rights**

- 6.1 PBB may amend, delete and/or add to any of these Additional Terms and Conditions from time to time with at least twenty-one (21) calendar days' prior notice at PBB's website or by any other approved medium of communication and such amendment, deletion or addition shall become effective on such date as PBB may determine.
- 6.2 In the event of a conflict, discrepancy or variance in the terms and conditions in the English Language version and Bahasa Malaysia version, the terms and conditions of the English Language version shall prevail.

The Additional Terms and Conditions and the Promotion Terms and Conditions (collectively "Terms and Conditions") shall be binding on the Customer who participates in this Promotion. The definitions in the Promotion Terms and Conditions shall apply unless otherwise expressly stated in the Additional Terms and Conditions. In the event of any inconsistency between the Additional Terms and Conditions and the Promotion Terms and Conditions, the Promotion Terms and Conditions shall prevail to the extent of such inconsistency.
