

## Visa Corporate Travel Solutions Terms and Conditions

1. The Promotion Period is valid from **1 June 2020 to 28 February 2021** (the “Promotion Period”).
2. This Promotion is open to all **Public Bank Visa Business/ Commercial Cardmembers(PB Cardmembers)**.
3. **“Savings from 5% up to 10% for individual tickets on selected airlines”** offer is valid for booking up to **31 December 2020** and subject to availability on selected booking class on dates and flights requested by the cardholders.
4. The **Complimentary Travel Insurance under Essential Plan up to 5 days for Domestic & International destinations** is for every qualifying transaction of purchase of flights, accommodation and other travel related goods and services settled with Visa Business Cards/ Visa Commercial Cards in Corporate Information Travel Sdn Bhd(CIT) within the promotion period, the cardholder is entitled to complimentary travel insurances per trip covering domestic destinations and following countries for 5 days, subject to first-come, first-served basis:

5. **Zero service fee for the first month** is applicable for the eligible cardholder for 30 calendar days from the first invoice issued by CIT to the cardholder.
6. For **Travel Management Reporting**, standard half-yearly or annual travel expense report is **available upon request**.
7. For **the one (1) complimentary air ticket upgrade from Economy class to Business class on any ASEAN route on Malaysia Airlines**, the following terms and conditions would be applicable:
  - a) One upgrade redemption per company.
  - b) Upgrade is offered on Malaysia Airlines flight based on ASEAN routes as below: Singapore, Indonesia, Thailand, Brunei, Philippines, Vietnam, Myanmar, Cambodia.
  - c) Upgrade is subject to availability on the right booking class. If the preferred upgrade flight is not available, alternative flight options will be offered.
  - d) The cost of the fuel surcharges and airport taxes for the upgrade redemption are included.
